

Good evening.

Per the city's website, "Saint Charles homeowners have the benefit of an 'insurance policy' on lateral sewers to their homes." The "Sewer Lateral Repair Program," established in 2003, can cover up to 90% (or up to \$7,500.00) of repairs on a city resident's sewer lateral, i.e., "the portion of your sewer line that runs from the exterior building wall to the city's sewer main line."

I have with me an estimate from April 27, 2022 totaling \$7,882.00 for extensive sewer work done on Mayor Dan's residence at 1022 S Main St. This work entails the re-routing of a sanitary drain, extending into the home's crawl space and sun room. Mayor Dan was then approved for a reimbursement of \$7,061.20 from the Sewer Lateral Repair Program on May 3, 2022. How was it that work so clearly outside of the scope of the Sewer Lateral Program was eligible for reimbursement to the Mayor? Did Mayor Dan misuse the Sewer Lateral Repair Program through his position as Mayor?

I'd also like to note that an expense of \$7,061.20 also appears on a Mayoral expense report from May of 2022 and appears to have been reimbursed again, this time by the city of St. Charles. Mayor Dan, if this was truly a residential expense, why did it appear on your list of expenses for reimbursement from the city? I will be filing a sunshine request to find out how this expense was paid for and with whom it was discussed.

Also, I'll address one comment of many the Mayor has recently posted on Facebook. It reads, "Tommy, I guess if you can't win an election, the next best thing is to try to work for a recall. Mayor Dan." This is in response to someone sharing our petition signature times and locations. To clarify, Mayor Dan, this movement is not about who will replace you. It is about holding you accountable for your actions. This isn't a political game, and to think it is would be making a mockery of the livelihoods, homes, and values of the constituents you claim to serve. We are volunteering our time, our talents, and our resources simply because we know it is the right thing to do. And, if it seems hard to believe that a recall movement could be made up solely of ordinary, everyday folks with strong convictions and a genuine hope for qualified leadership, you've been in politics for too long.

All we ask for is transparency, integrity, and accountability. Have a good evening.
